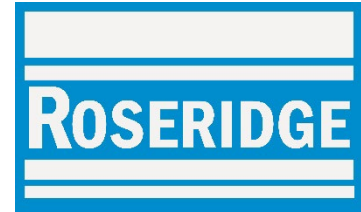


ROSERIDGE WASTE MANAGEMENT SERVICES COMMISSION 2025 RATE SCHEDULE



The following fee schedule outlines the disposal rates for various waste materials at Roseridge Waste Management Services Commission for 2025. These rates apply to landfill waste, recyclable materials, organics, soil, and other fees. Please review the listed charges to ensure compliance with disposal requirements and proper waste handling procedures.

1. Landfill Waste

| Material | Minimum Charge | Rate |
|--|----------------|----------------|
| Regional Residential (Roseridge cash customers) | 250 kg | \$69.50/tonne |
| Commercial | 1 tonne | \$69.50/tonne |
| Special Waste | 1 tonne | \$110.00/tonne |
| Commercial Carcass (Admin Fee per Item) | | \$10.00 each |

2. Recyclable Materials (Within Region Only)

| Material | Minimum Charge | Rate |
|--|----------------|------------------|
| Asphalt & Concrete (Pavement, Sidewalks, Bricks) | 1 tonne | \$20.00/tonne |
| Refrigerant Removal Charge (Fridges, Freezers, A/C Units, Water Coolers) | | \$20.00 Per Item |
| RV Fridges | | \$35.00 Per Item |

3. Organics

| Material | Minimum Charge | Rate |
|---------------------|----------------|---------------|
| Commercial Organics | 1 tonne | \$65.00/tonne |
| Trees / Branches | 1 tonne | \$56.73/tonne |
| Wood Chips | 1 tonne | \$10.00/tonne |

4. Soil

| Material | Minimum Charge | Rate |
|---|----------------|-------------------------|
| Waste Soil Requires Application No Beneficial Use | 1 tonne | \$45.00+ |
| Beneficial Soil Requires Application Must Meet Cover Material Criteria | 1 tonne | \$19.00 - \$30.00/tonne |
| Commercial Clean Fill Dirt (Without Sod, Must Meet Tier 1 Soil Guidelines) | 1 tonne | \$12.00/tonne |
| Residential Cover Material (Wood Chips, Gravel, Clay) | | Free |
